Monkeypox: Separating Fact from Fiction



On July 28, 2022, the San Francisco Public Health Director issued a local public health emergency for MPX to harness resources, including efforts to obtain additional vaccine supply. Both State and Federal health emergency declarations soon followed.

Acting quickly, the Vaccination Clinic at Zuckerberg San Francisco General Hospital established San

Francisco's largest vaccination clinic, supplying city residents with more than half of the city's total supply of the MPX vaccine.

With a long history of addressing infectious diseases and combatting potential stigma, the Foundation was pleased to host Dr. Lisa Winston, Epidemiologist at Zuckerberg San Francisco General Hospital, virtually to address the evolving MPX landscape

and discuss how the local response to this disease is based both in our history and in our commitment to equitable health care.
